

While production orders become increasingly diverse, there is a pressing need for manufacturers to upgrade their production modes as they play a significant role in creating value for them and reinforcing their core competence.

The Chinese got acquainted with the manufacturing execution system ("MES") rather late when compared with other IT systems. In contrast to ERP system, MES was developed purely for manufacturing process. It is mainly used to handle goods movement in the "people, money and goods" networking and production in the "production, procurement and marketing" networking. By integrating engineering data management system, inventories management system, production management system and quality management system, it helps managers to monitor and control the entire production process which ranges from production planning and scheduling, production process reporting to stock tracking. Therefore, they can get access to all production information and management production activities easily.

Integration of PLM + ERP + MES:

During the production process, managers can make use of product lifecycle management ("PLM") system to merge the materials, bill of materials and production process information into ERP and MES systems. Meanwhile, MES system serves as an operational administrator and is used to manage the physical production process.
